



2026 Corpus Christi 7 Day Cell Phone Project Participation Agreement

This Agreement is made between the undersigned Participant/Team Leader (the “Participant”), representing the film team known as _____ (“Team”), and Corpus Christi 7-Day Film Project (“CC7D”). It governs the Participant’s involvement in the 2026 CC7D Cell Phone Project and the creation of a short film or video (the “Film”).

1. Follow the Official Rules

The Participant agrees to follow all CC7D Cell Phone Project Official Rules (the “Filmmaking Rules” and “Competition Rules”) found at <http://www.CC7Day.com>. CC7D may disqualify any Film that does not meet these rules.

2. Production Responsibilities and Costs

The Participant is solely responsible for all aspects of producing the Film—this includes obtaining crew and cast, securing equipment, locations, and all other necessary items—and for covering any related costs. CC7D will provide the event, a screening opportunity for the Film, and any prizes as described in the Official Rules.

3. Copyright, Releases, and Use Rights

- (a) The Participant confirms that all rights (including copyrights) and necessary permissions (releases, waivers, etc.) for all materials in the Film have been secured as they are specified in the CC7D Cell Phone Project Official Rules.
- (b) The Participant keeps full copyright ownership of the Film. However, the Participant grants CC7D an exclusive, worldwide, and perpetual license to use, reproduce, screen, broadcast, and promote any still images or footage from the Film—this includes digital, online, and emerging technologies—solely for advertising and promoting the Project and CC7D.

4. Indemnification and Warranties

- (a) The Participant represents that they are free to sign this Agreement and have secured all necessary rights and releases for the Film.
- (b) The Participant agrees to defend and indemnify CC7D (and its affiliates, directors, officers, employees, etc.) against any claims, damages, or legal costs that arise from the Film’s production or use—but only if such issues result from the Participant’s failure to obtain proper rights or from their negligence or breach of this Agreement.

5. No Monetary Compensation

Participation is voluntary and does not include monetary payment. In exchange, the Participant receives the opportunity to have their Film screened at the Project, possible future screenings, and publicity.

6. Limitation of Remedies and Liability

- (a) If CC7D breaches this Agreement, the Participant’s remedy is limited to recovering only direct, compensatory damages. The Participant waives any right to seek injunctive or other equitable relief.
- (b) CC7D will not be liable for any indirect, special, or consequential damages. In any case, CC7D’s total liability will not exceed the entry fee paid by the Participant.

7. Assignment and Relationship

- (a) The Participant may not transfer this Agreement or any obligations hereunder without CC7D’s written consent.
- (b) CC7D may assign its rights or obligations under this Agreement at any time.
- (c) The Participant is an independent contractor, not an employee or agent of CC7D.

8. Governing Law

This Agreement is governed by the laws of the State of Texas.
