- Rights to incorporate the footage into promotional content, trailers, or other creative works.

This includes the right to use footage of the property to promote the Corpus Christi 7 Day Film Project (CC7D) in future advertising, campaigns, or events.

4. Waiver of Claims: I waive any right to: review or approve how the property appears in the final project or promotional materials, or make claims for trespass, defamation, invasion of privacy, or how the property is portrayed. I understand that the team is not obligated to use footage shot at my property in the final film or promotions.

5. Legal Confirmation: I confirm that:

- I have the legal authority to sign this agreement and grant these rights.
- No other permissions are required to use the property as described.
- This agreement is governed by the laws of the State of Texas and applies even if signed after filming has occurred.
