

## **Corpus Christi 7 Day Film Project Participation Agreement**

This agreement is between	("Participant/Team Leader"), representing the film
team	("Team"), and Corpus Christi Film Projects, the organizing entity behind
the Corpus Christi 7 Day Film Pro	eject ("CC7D").

By signing this agreement, Participant agrees on behalf of themselves and their Team to participate in the 2025 Corpus Christi 7 Day Film Project ("Project") and to create a short film ("Film") in accordance with the terms below:

- **1. Rules & Eligibility:** Participant agrees to follow the official Filmmaking Rules and Competition Rules as posted on <a href="https://www.cc7day.com">www.cc7day.com</a>, which are incorporated into this agreement by reference. Films that violate these rules may be disqualified.
- **2. Responsibility:** Participant is solely responsible for securing their own cast, crew, gear, locations, and any associated costs. Corpus Christi Film Projects provides the competition structure, screening platform, and potential awards.
- **3. Legal Rights & Releases:** Participant affirms they will secure all necessary rights and releases for the Film, including:
- Talent Releases
- Location Releases
- Music and Soundtrack Rights
- Any additional permissions related to content in the Film

Participant warrants that the Film does not infringe upon the rights of any third party.

- **4. Indemnification:** Participant agrees to hold harmless Corpus Christi Film Projects and its officers, agents, and assigns from any claims related to the creation or use of the Film, including legal costs.
- 5. No Compensation: Participant understands that no financial compensation will be provided.

Consideration includes:

- Public screening of qualifying films
- Eligibility for awards
- Opportunities for recognition and exposure
- **6. Legal Recourse:** In the event of any dispute, Participant waives the right to seek injunctions or stop the Film from being shown. Remedies, if any, are limited to direct (not consequential or punitive) damages.
- **7. Independent Contractors:** This agreement does not create an employee/employer relationship. Corpus Christi Film Projects may assign its rights and obligations under this agreement; Participants may not do so without prior written consent.
- **8. Limitations on Liability:** Corpus Christi Film Projects' total liability under this agreement shall not exceed the entry fee paid by Participant.
- **9. Copyright & Usage Rights:** The Film will be jointly owned by the Participant and Corpus Christi Film Projects as co-authors. Rights are divided as follows:
- Participant: May use, distribute, or submit the Film anywhere they wish.
- Corpus Christi Film Projects: May use stills, clips, or the full Film in perpetuity to promote or advertise the Corpus Christi 7 Day Film Project or other projects organized by Corpus Christi Film Projects including through future rebranding or name changes.

**10. Organizational Continuity Clause:** Participant understands and agrees that the name of the Corpus Christi 7 Day Film Project or its producing entity may evolve over time (e.g., new branding, new producers, organizational changes). Regardless of name or personnel changes, Corpus Christi Film Projects and its successors retain the right to use submitted films for promotional or archival purposes.

11. Governing Law: This agreement is governed by the laws of the State of Texas.
