- (b) CC7D shall have the following rights: To copy, screen, show, exhibit, telecast, broadcast, advertise, and market still and moving images from the Film for the sole purpose of advertising, promoting and publicizing the Project or CC7D for perpetuity. When Film is used for above purpose printed or verbal notation of Team Name and Team Leader's name is to be referenced.
- (10) This agreement shall be governed by and construed in accordance with the internal laws of the State of Texas, without any reference to its conflicts of law provisions.
