This includes the right to use my performance or work to promote the Corpus Christi 7 Day Film Project (CC7D) in future events, campaigns, or media.

4. Ownership and Modification: The Project and Filmmaker are the exclusive owners of all footage and content I contribute. They may edit, modify, remix, and use it in any way, without my approval. I waive any "moral rights" or claims to how it's used or presented.

5. Warranties and Representations: I confirm that any materials I bring or contribute (e.g., songs, writings, designs) are either owned by me or used with permission. I have the authority to sign this agreement and grant these rights.

6. Risk and Liability: I voluntarily assume any risks (physical, emotional, or otherwise) involved with participation in the film, including travel, location hazards, or on-set incidents. I release the Project and all affiliated parties from liability, including claims for injury, defamation, or emotional distress.

7. Release of Claims: I release the Project, CC7D organizers, filmmakers, sponsors, and partners from any present or future claims related to this film and its use. This includes known or unknown claims and applies even if I later change my mind about participation.

8. Legal Details: This agreement is governed by Texas law. If any part of it is unenforceable, the rest still applies. I understand this is binding and that I've had a chance to consult legal counsel if I chose to.
